AMENDMENT TO DECLARATION OF BUILDING
RESTRICTIONS AND COVENANTS

THIS AMENDMENT is made this 19th day of March, 2004 by
PHEASANT RIDGE DEVELOPMENT COMPANY, INC., an Indiana corporation, of
58573 Glenriver Drive, Goshen, Indiana 46526 ("Declarant").

Background

Declarant is the Declarant under the Declaration of Restrictions dated June 29, 1998 and recorded June 30, 1998 in Liber 843, Page 160 of St. Joseph County Records (the "Declaration"). The Declaration imposed certain building restrictions and covenants on the "Property" as defined and described therein. Section 23 of the Declaration expressly authorizes the Declarant to amend the Declaration to remove portions of the Property from the terms of the Declaration. Declarant now desires to amend the Declaration to remove the property described in attached Exhibit "A" hereto from the Declaration (the "Released Property").

NOW, THEREFORE, IN CONSIDERATION OF THE FOREGOING BACKGROUND AND THE TERMS AND CONDITIONS DESCRIBED HEREIN, THE DECLARANT HEREBY AMENDS THE DECLARATION AS FOLLOWS:

1. Release of Released Property. Pursuant to the authority reserved to the Declarant in Section 23 of the Declaration, the Released Property is hereby forever discharged and released from the terms of the Declaration.
2. Background. The Background set forth above is hereby incorporated into the terms of this Amendment to the Declaration.
3. Amendment. Except as amended by this Instrument, all terms, provisions, restrictions and covenants of the Declaration are hereby ratified and confirmed.
